2. This form should be submitted at least two months prior to the date you plan to begin classes. This is required to allow sufficient time to process and mail the Form I-20 or Form DS-2019.
3. Financial aid for international students attending Calvin Seminary is very limited. In most cases, international students who attend Calvin Seminary meet their expenses with their own funds, other aid from their home countries, and/or with scholarships, other grants or student loans. Only **on-campus** employment is allowed by the US government and opportunities for this are limited.
